

PURCHASING AND USING A CUSTOM EMAIL DOMAIN WITH GOOGLE WORKSPACE

CUSTOM EMAIL DOMAINS



Introduction:

From enhanced security and control to a more professional look and feel, there are many reasons why a company would want to purchase and use a custom domain for their email. This article will outline how quick and easy purchasing and setting up a custom domain is with one of the most popular business email platforms, Google Workspace.

Pricing:

Google Workspace offers several different plans that vary in price and features. **For the purposes of this demonstration**, **we went with the "BUSINESS STANDARD" plan** which retails at \$12/user/month. If fewer features are required, the "Business Starter" plan can be purchased for \$6/user/month. A full pricing matrix can be found here: **Google Workspace** (Formerly G Suite): Pricing Plans.

Getting Started:

The Google Workspace portal is located here: <u>Google Workspace | Business Apps & Collaboration Tools</u>. Click on "GET STARTED" to begin.



Setup:

• The setup will start by asking you some basic questions about your organization. Fill in these required fields and hit "NEXT."

• Since we don't already own a custom domain, we'll **click the "NO, I NEED ONE" option** here to purchase one through Google.



Choosing a Domain Name:

Now we'll need to find the domain name we want to purchase. *You may need to get a little creative when searching for a domain since the one you want may already be taken.* In this example for instance, I wanted to purchase LeederLaw.com but it was already taken. I ended up purchasing LeederLawyers.com for \$12/year.

• Once you find your domain name to purchase, click "NEXT."

Creating Your Account (continued)

- Confirm that all of the information on the page is correct and edit any incorrect information if needed.
- Enter the payment information you'd like to use for your domain purchase and monthly Google Workspace subscription.

Leave the default options for "Make my domain registration info private" and "Register my domain with" as shown below.

• Select "AGREE AND CONTINUE" when done.

We'll now be prompted to go to the admin portal:

• Select "CONTINUE TO ADMIN CONSOLE."
